Students classified as dependent as defined by the Free Application for Federal Student Aid (FAFSA) may file this petition to be reclassified as independent based upon adverse family conditions. A successful appeal will document that all financial and emotional contact with parents has been severed as a direct result of the adverse family condition. Please complete all steps as outlined in this form and return it to Edgewood Central.

Examples of eligible circumstances include:

- Severe estrangement from parents
- > An unsafe domestic environment
- Unknown whereabouts of parents

Examples of ineligible circumstances include:

- > Financial hardship
- > Unwillingness of your parent(s) to provide parental data on your financial aid application
- Unwillingness of your parent(s) to financially support your education
- A student's demonstration of financial independence, self-sufficiency or living on their own

REQUIRED DOCUMENTATION: ALL REQUIRED DOCUMENTS MUCH BE ATTACHED TO THIS APPEAL FOR CONSIDERATION.

- 1. STUDENT STATEMENT: Please attach a letter of explanation and that will answer ALL the following:
 - ✓ The adverse circumstances that should make you an independent student.
 - ✓ Identify the location of your parent(s), if known.
 - ✓ Describe the last time you had contact with your parent(s) when, where, and the nature of the contact.
 - ✓ How have you provided for yourself (you may include support received from family and friends)?
 - ✓ Include copies of any court orders and/or decisions.
- 2. THIRD PARTY STATEMENTS Please attach a <u>MINIMUM of 2</u> statements from individuals that are familiar with your circumstances. These should be from unbiased community members such as a social worker, counselor, physician, clergy or teacher. At least one of these must be from a non-relative. They should address <u>ALL</u> of the following:
 - ✓ The length of time the person has known you.
 - ✓ How the person is aware of your situation and provide details about it.
 - ✓ To their knowledge, where the parents are located and date of the last contact with the student.
 - ✓ Include name, phone and email for follow up if necessary.
